Subject : Issuance of February 2018 Renewable Energy Certificates (RECs)

Dear REM Participants,

Please be advised that the RE Registrar has issued the RECs for FiT Compliance Mechanism and Non- FiT Compliance Mechanism corresponding to the February 2018 Billing Period today, **18 July 2022**.

All Mandated Participants (i.e. Distribution Utilities, Retail Electricity Suppliers and Generators Serving Directly Connected Customers) and Non-FiT RE Generators with issued RECs for the said period are requested to accomplish and submit via email the attached REC Validation Form on or before **02 August 2022, 05:00 PM.**

Please note that non-submission of the accomplished REC Validation Form on the said deadline shall be considered as confirmation of the RECs issued to your company/organization for the subject billing period. Any request for extension is discouraged.
