Subject : Issuance of March 2018 Renewable Energy Certificates (REC)

Dear REM Participants,

We thank all those who have submitted their REC Validation Forms relative to the review and confirmation of the February 2018 issued RECs. After our review and provision of responses to REM Participants with reported issues/concerns, the RE Registrar concluded that the issued RECs for February 2018 are all correct and no adjustment will be reflected in the March 2018 REC issuance.

Also, please be advised that the RE Registrar has already issued the respective RECs for FiT Compliance Mechanism and Non- FiT Compliance Mechanism corresponding to the March 2018 Billing Period today.

In this regard, we would like to request all Mandated Participants (i.e. Distribution Utilities, Retail Electricity Suppliers and Generators Serving Directly Connected Customers) and Non-FiT RE Generators with issued RECs for the said period to accomplish the attached REC Validation Form and submit it via email to [reregistrar@wesm.ph](mailto:reregistrar@wesm.ph) or through the Secured File Transfer Protocol (SFTP) at <https://ftp-in.wesm.ph/login> on or before **24 August 2022, 05:00 PM.**

Please note that non-submission of the accomplished REC Validation Form on the indicated deadline shall be considered **as confirmation of the RECs issued to your company/organization** for the subject billing period. Any request for extension is highly discouraged.

The REC Manual Computation Template for the validation of March 2018 RECs issued to Mandated Participants from FIT-eligible generation facilities can be accessed through the SFTP via <https://ftp-out.wesm.ph/login> Kindly log-in to your respective SFTP account to download a copy of the said template.
3. To correctly validate the issued RECs for March 2018, the carry-over value per FIT-eligible RE Generator in February 2018 must be indicated in the Factor B Column of the March 2018 REC validation template. For your ready reference of the carry over values, we have included in separate sheets the January 2018 and February 2018 templates in the March 2018 validation template. Please make sure that you also update your metered quantity values for the subject billing periods in the January and February 2018 templates.
