Subject : Issuance of April 2018 and May 2018 Renewable Energy  
Certificates (REC)

Dear REM Participants,

We thank all those who have submitted their REC Validation Forms relative to the review and confirmation of the March 2018 issued RECs. After our review and provision of responses to REM Participants with reported issues/concerns, the RE Registrar concluded that the issued RECs for March 2018 are all correct and no adjustment will be reflected in the April 2018 REC issuance.

Also, please be advised that the RE Registrar already issued the respective RECs for FiT Compliance Mechanism and Non- FiT Compliance Mechanism corresponding to the April 2018 and May 2018 Billing Periods and are already accessible through the Philippine Renewable Energy Market System (PREMS).

In this regard, we would like to request all REM Participants to review their issued RECs for the said billing periods via the PREMS and accomplish the attached REC Validation Form. Please note that non-submission of the accomplished REC Validation Form on the indicated deadline shall be considered **as confirmation of the RECs issued to your company/organization** for the subject billing periods. Any request for extension is highly discouraged.
