RECENT EVENTS

On 28 July 2022 the Ceremonial Launch for the Renewable Energy Market's Interim Commercial Operations (REM ICOP) was celebrated before REM Participants and representatives from the DOE with speeches from PEMC's President, Atty. Leonido J. Pulido III, and representative from the UNDP, Dr. Selva Ramachandran. The Ceremonial Launch was capped off with an information session about the REM for the participants in the afternoon.

Following the REM ICOP launching event, the RE Registrar actively participated in the Information and Education Campaign (IEC) on Various Renewable Energy Policies and Mechanisms and Focus Group Discussions (FGD) on Renewable Portfolio Standards (RPS) with REM Participants in Luzon, Visayas, Mindanao, and Metro Manila in August and September 2022. The RE Registrar provided updates on the REM implementation as well as hands-on training to the participants on the use of the Philippine Renewable Energy Market System (PREMS) during the said events.



Moreover, to expand the understanding of REM Participants, the RE Registrar conducted a total of four (4) online trainings for REM Participants covering the following subjects: REM Overview, REM Process and Transactions, and PREMS Hands-on Training.

REM REGISTRATION UPDATE

As of 31 August 2022, the total number of approved REM membership applications is 266 out of the 284 expected participants, with 12 applications still pending for approval. Meanwhile, 6 participants have yet to submit their application for membership to the RE Registrar.
