Subject : **Validation of Renewable Energy Certificates from FiT-Eligible Facilities for September 2018- December 2018**

Dear **RE Market Participants**,

With reference to the attached REM Advisory No. 2023-03, please be informed that the RE Registrar has completed the re-issuance of the Renewable Energy Certificates (REC) for the renewable electricity generated by **FiT-Eligible facilities in September 2018 to December 2018**.

In this regard, we request all REM Participants to-

1. Review the RECs issued to your company via the Philippine Renewable Energy Market System (PREMS) for the said billing periods; and
2. Accomplish and sign the REC Validation Form herein attached and submit it to us via email to [reregistrar@wesm.ph](mailto:reregistrar@wesm.ph) or through the Secured File Transfer Protocol (SFTP) at <https://ftp-in.wesm.ph/login> on or before **15 March 2023, 05:00 PM**. Any request for extension for validation is highly discouraged.

Please note that non-submission of the accomplished and signed REC Validation Form on the indicated deadline shall be considered **as confirmation on the correctness of the RECs issued to your company/organization** for the subject billing periods.

1. Log-in to your respective PREMS account to view and verify the above data.
2. The updated REC Manual Computation Templates for the validation of FIT-eligible RECs for September 2018 to December 2018 are accessible through the SFTP via <https://ftp-out.wesm.ph/login>. Kindly log-in to your respective SFTP account to download a copy of the template.
3. Some FiT RE facilities have no actual generation from the previous month. Hence, kindly check the carry-over value per FiT-eligible RE generator from the older months and input the value in the Factor B column of the month you are reviewing.
