

## 2024 MARKET SURVEILLANCE COMMITTEE WORK PLAN

In accordance with the WESM Rules and relevant Market Manuals, the Market Surveillance Committee (MSC) aims to provide assistance to the PEM Board, by way of its monitoring and assessment on the activities of market participants, in ensuring efficiency and competitiveness in the wholesale, retail, and reserve markets. With this, the Committee strives to focus in providing timely and relevant periodic assessment reports and market studies, as well as other activities relevant in the performance of its governance functions.

Moreover, as part of its monitoring responsibilities, PEMC, through the MSC, is mandated by the ERC-PEMC Memorandum of Agreement (MOA) to issue a Notice of Possible Commission of ACB to the ERC if there is sufficient ground to believe that conduct of ACB has been committed.

The activities in the Work Plan are aligned with PEMC’s 2024-2026 Corporate Strategic Plan and shall be updated as necessary or as directed by the PEM Board, PEMC Management, DOE, or ERC.
