Addition to RCC Resolution No. 2020-14 on the Proposed WESM Rules and WESM Manual on Procedures for Changes to the WSM Rules, Retail Rules and Market Manuals

WHEREAS, Chapter 8 of the WESM Rules and the Procedures for Changes to the WESM Rules, Retail Rules and Market Manuals (“Rules Change Manual”) provide the criteria, method and procedures for changes to the WESM Rules, Retail Rules and Market Manuals;

WHEREAS, on 15 May 2020, the RCC approved amendments to the WESM Rules and Rules Change Manual to enhance the rules change process and incorporate policies under the DOE Circulars issued on WESM governance and approved the endorsement of the proposal to the PEM Board for approval and subsequent transmittal to the DOE for promulgation;

WHEREAS, the PEM Board, on 27 May 2020 per PEM Board Resolution No. 2020-24-13, approved the Proposed Amendments to WESM Rules and WESM Manual on Procedures for Changes to the WSM Rules, Retail Rules and Market Manuals, and on 08 June 2020, submitted the proposal to the DOE for approval in accordance with WESM Rules;

WHEREAS, the DOE, on 31 July 2020, posted the draft Department Circular (DC) adopting the proposed amendments to solicit further comments from market participants and other interested parties, and on 10 and 15 December 2020,¹ conducted virtual public consultation for Luzon and Visayas-Mindanao leg respectively, to solicit further inputs or comments for the finalization of the DC;

WHEREAS, through a letter dated 23 March 2021, the DOE informed PEMC and the RCC that while it has no objections on the proposal, including on the proposed extension on the effectivity period of urgent amendments, the DOE deems that it is necessary to clarify the process of approval, period of effectivity, and endorsement as general amendment to DOE of the urgent amendments under WESM Rules Clause 8.4.1.2;

WHEREAS, in same letter, the DOE pointed out that WESM Rules 8.4.1.2 clearly specifies in its first paragraph that the DOE will approve and promulgate all rules change proposals, however, its second paragraph provides a conditional approval by the PEM Board for the urgent proposals that seemingly contradicts the first paragraph;

WHEREAS, during its 177th Regular Meeting on 16 April 2021, the RCC discussed the proposed rewording of WESM Clause 8.4.1.2 by the Secretariat with the following rationale:

- To be consistent with the WESM Rules Clauses 8.4.1.1 (on classification of rules changes) and 8.4.1.3 (on rules change manual);
- To be consistent with Rules Change Manual Section 7.4 (on the effectivity of urgent amendments);

- To retain the proposed extension of the effectivity by the PEM Board of six (6) months as proposed by the RCC under the subject RCC Resolution No. 2020-14; and
- To clarify the approval of Minor/General amendments, consistent with the current WESM Rules Clause 8.4.1.2;

WHEREAS, the RCC noted that its rewording to the originally proposed extension of the effectivity period of urgent amendments for six (6) months in WESM Rules Clause 8.4.1.2 should be reflected in the corresponding proposed new provision in the Rules Change Manual Section 7.5;















NOW THEREFORE, we, the undersigned, on behalf of the sectors we represent, hereby resolve via electronic communication platforms, as follows:
