SUMMARY OF OBSERVATION

- Twelve (12) new Contestable Customers (CCs) registered during the July 2024 billing period, nine (9) of which came from Luzon.
- Additional two (2) new CCs from Mindanao registered under the Retail Competition and Open Access (RCOA).
- Eleven (11) out of the twenty (20) switches were due to the expiration of supply contracts
- Reasons for cessation of participation in the RCOA Market were due to the following:
 - Discontinuation of supply of electricity supply in preparation for the planned demolition of the facility
 - Transfer of service to another customer
 - Merging with another customer







MONTHLY CONSUMPTION







MARKET CONCENTRATION


Herfindahl-Hirschman Index (HHI)







RE SUPPLIERS






Keeping with the trend from the previous months, Ayala Group remained to be the top market participant group with the highest percentage share for both the number of engaged GEUs and served energy consumption.




