

**WHOLESALE ELECTRICITY SPOT MARKET
RULES CHANGE COMMITTEE****RESOLUTION NO. 2017-13****Proposed Amendments to the WESM Rules and WESM Manual of Procedures
for Changes to the WESM Rules Issue 2.0**

WHEREAS, the Rules Change Committee (RCC), as part of its 2017 work plan, proposed to amend the WESM Rules and WESM Manual of Procedures for Changes to the WESM Rules Issue 2.0;

WHEREAS, the proposal was discussed by the RCC during its meetings held on 07 July, 10 August and 14 September 2017, and was thereafter approved for publication to solicit comments from WESM Members and stakeholders;

WHEREAS, the proposal sought to:

- (i) reflect in the WESM Manual, the changes per DOE DC 2015-07-0013¹, which provides the revised procedures for approval of amendments to the WESM Rules and Market Manuals requiring the approval of the DOE, as well as for new Market Manuals;
- (ii) amend the specified timeline in the WESM Manual to cover the applicable process for rules change procedures and to be consistent with the WESM Rules; and
- (iii) reflect clerical and minor amendments for clarity and consistency;

WHEREAS, after thirty (30) working days from the date of publication of the proposal, comments were received from the DOE and MERALCO;

WHEREAS, the RCC deliberated on the proposal during its 135th Regular Meeting on 10 November 2017, giving due consideration to the comments received from DOE and MERALCO;

WHEREAS, the procedures for certification of Urgent Amendments was proposed to be amended by the DOE, which provides that the RCC members shall assess the urgency of the amendments based on the criteria provided in Sections 3² and 4³ of the manual;

WHEREAS, the RCC adopted DOE's recommendation to invite proponents during the RCC deliberation of the proposed amendments in order to respond to the received written submissions from the WESM stakeholders;











NOW THEREFORE, we, the undersigned in behalf of the sector we represent, hereby resolve as follows:
