RESOLUTION NO. 2016-01

**Proposed Amendment to the WESM Rules and Technical Committee Manual
Issue No. 1**

WHEREAS, on 15 September 2015, the Rules Change Committee received the Technical Committee's Proposed Amendment to the WESM Rules and Technical Committee Manual Issue 1;

WHEREAS, said proposal sought to update the first issuance of the Technical Committee Market Manual and revise the procedures in the conduct of technical study and review;

WHEREAS, the proposal was presented before the RCC during the 105th RCC Meeting held on 7 October 2015, and was thereafter approved for posting to solicit comments of participants;

WHEREAS, the proposal was published on 8 October 2015, with the corresponding notice to participants;

WHEREAS, during the 107th RCC Meeting held on 2 December 2015, the RCC deliberated upon the Proposed Amendments to the WESM Rules and the Technical Committee Manual Issue No. 1, giving due course to the comments (Annex A) received from MERALCO;

WHEREAS, in the same meeting, the RCC approved the Proposed Amendment to the WESM Rules and Technical Committee Manual Issue 1, subject to the revisions discussed by the Committee, and agreed on its endorsement to the PEM Board;

WHEREAS, in a subsequent meeting of the RCC, on 13 January 2016, the RCC reviewed its approval based on the comments received on a provision of the proposal as approved by the RCC, specifically the matter on who to submit the studies to, apart from the concerned requesting parties;

WHEREAS, finding merit in the concerns raised, the RCC again reviewed the specific provision and subsequently approved its revision to the provision as discussed;

NOW THEREFORE, we, the undersigned and in behalf of the sector we represent, hereby resolve as follows:

RESOLVED, that the Proposed Amendment to the WESM Rules and Technical Committee Manual Issue No. 1, as revised is hereby approved by the RCC;


